Section 8.22

- Motion Koester, support Papenhagen to strike all of the wording in 5, 6, and 8 of Part A. *Motion carried*
- Motion Koester, support Isley to strike "thirty (30) foot high hill or" in Part B/3. Motion carried.
- ➤ Motion Whited, support Koester to strike all of 5, 6, and 8 in Part B. *Motion carried*.
- Motion Isley, support Papnhagen to strike wording in Part B/10 and replace with "Operations may be limited to hours set by the Township Board." Motion carried.

Section 8.24

Motion Isley, support Koester to strike all the wording in Section 8.24 of proposed Ordinance, replacing it with the wording from 8.4 of the current Zoning Ordinance and to amend first line by inserting "and/or accessory structure" after dwelling unit. Motion carried.

Section 8.25

Motion Isley, support Papenhagen to add "D. All institutions must meet all County, State, and Federal regulations. Motion carried.

Section 8.26

- Motion Isley, support Koester to add in the first sentence of Part A. "or public right-of way" after "parcel".
 - -In Part B, add parentheses around "other than the incinerator, receiving area, and waste storage."
 - -Add a period after "right-of ways."
 - -Strike "however, any" and amend remaining sentence as "Structure of building and materials, excluding discharge stacks, shall not be higher than forty (40) feet." *Motion carried*
- Motion Isley, support Koester to amend Part O by inserting after the words "provided to" in the second sentence "collect and store liquids that have been used for washing until transfer to the approved disposal site." Motion carried.
- Motion Isley, support Papenhagen to add the wording from Section 8.37, Part B/12 and B/13 as Q and R, respectively. *Motion carried*.
- Motion Whited, support Koester to pay \$44.00 per meeting for a CLSS Committee representative. *Motion carried*.
- Supervisor Isley calls Special Meetings for the purpose of reviewing the proposed Zoning Ordinance to be held on February 13th and 20th.
- Motion Isley, support Pooley for Supervisor Jim Isley to submit the 2017 Road Project Proposal to the LCRC for bids to present to the Board for consideration. *Motion carried*.
